NOTICE IS HEREBY GIVEN that the City Council of the City of Riggins, Idaho will hold a public hearing for consideration of the proposed budget for the fiscal period October 1, 2021 to September 30, 2022 pursuant to the provisions of Section 50-1002, Idaho Code. The hearing, previously scheduled for August 11, 2021, has been rescheduled for Wednesday, September 8, 2021 at 6:00 p.m. at the City Hall Council Chambers, 126 North Main Street, Riggins, Idaho. All interested persons are invited to appear and show cause, if any, why such a budget should or should not be adopted. Copies of the proposed budget in detail are available at City Hall during regular office hours (10 a.m. to 5 p.m. Monday – Friday). City Hall is accessible to persons with disabilities. Anyone desiring accommodations for disabilities related to the budget documents or to the hearing, please contact the City Hall 208-628-3394 at least 48 hours prior to the public hearing. Note that the figures below include proposed projects that may or may not be completed due to the availability of revenue sources, including grant funds.

"What is WASTEWATER?"

- Wastewater is dirty water that leaves your house through drains, clothes washers, dishwashers, and when you flush the toilet.
- This water travels to a collection facility where it is treated.
- Wastewater facilities that treat over 2,500 gallons per day are classified as public and are subject to State and Federal rules.
- Wastewater facilities require skilled specialists to run them and make sure your waste is handled in a sanitary way.

AMBULANCE SUBSCRIPTION MEMBERSHIPS AVAILABLE

The City of Riggins Ambulance Subscription Membership applications are now available with an effective date of **October 1, 2021 (renewal is required each year).**

An ambulance transport can cost between \$800 and \$1,300. This program works like a supplement to your existing insurance or Medicare/Medicaid, or fills the financial gap if you don't already have insurance.

Individual membership \$ 100

Family Membership \$ 100

Lifetime Membership \$1,000

(Any unmarried dependent children under the age of 25, or other students that have court documented guardianship papers)

All emergency calls resulting in a transport by Riggins Ambulance are covered under this program.
